This Online Appendix accompanies the article, *Legal Analysis, Policy Analysis, and the Price of Deference: An Empirical Study of Chevron and Mayo*. It reports whether the terms used in the Article serve as effective proxies for the concepts they are intended to describe. In the cases where the terms are not used as expected, a footnote explains the deviation. If a particular term occurred more than once in a document, the number of occurrences is listed in parentheses.
